established coaches/mentors/consultants.

Duties and Responsibilities

Promotes and supports the early childhood care and education workforce in Kansas.

- Facilitates coaching and technical assistance in groups and/or one on one with early childhood care and education professionals working on program growth, which will include progression within the L2Q -QRIS.
- Phone, virtual, and onsite visits are provided on demand.
- Assists with the development of benchmarks and indicators that make up the Links within L2Q QRIS and financial incentive requirements.
- Stays current on research, evidence-based practice and policy.
- Researches grant opportunities with government agencies and various community entities.
- Demonstrates flexibility in hours and days of service (i.e., offer nontraditional days and hours.)
- Demonstrates effective outreach methods to meet the needs of the child care workforce in Kansas.
- Promotes public awareness of opportunities available through multiple media methods.
- Assists with a resource library for early childhood care and education programs to enhance the continuous quality improvement process.
- Works with a high level of communication and in cooperation with other consultation services.
- Collaborates with other agencies and organizations who provide training and/or technical assistance to improve consultants' practices and skills.
- Collects and submits required documentation and supporting data as required.
- Delivers or supports professional development when needed.
